FedEx Demand – Residential Delivery Charge

Who Pays: Applies to customers shipping over 20,000 residential packages in a week.

How It's Calculated: Surcharge is based on how much a customer's weekly volume exceeds their average volume from June 2025. The charge increases in tiers as shipment volume grows

Additional Details: The surcharge is on top of existing fees, and discounts don't apply. During holiday weeks, volume is adjusted to reflect fewer operating days.

UPS Demand Surcharge

Who Pays: Applies to customers with more than 20,000 packages in a week across Ground, Sure Post, and Air Residential services.

How It's Calculated: Surcharge is applied to any weekly volume exceeding 105% of a "Baseline" set in June or September 2025. The highest tier surcharge for the week applies to all excess

Additional Details: Similar to FedEx, UPS adjusts surcharges during holiday weeks based on the number of operating days.
